Item 4 EBA Reports and Updates

4.A Board Administrative Activities: March 16, 2019, thru May 10, 2019

Executive Board Administrator reported PEALS FY19 Revenue & FY18 Revenue previous year in comparison. AS400 breakdown of Year-To-Date Expenditures are at \$143,189, and Current Revenue collected at \$250,142.

Bank of Hawaii statements for March and April 2019 were presented. Balance of \$3,810.45, respectively. No checks were written.

FY18 Bi-Annual Report of Revenue and Registrant's breakdown was reviewed. EBA Borja has not submitted a copy to the OPA Office as he wanted Board's review prior to submission.

5.A Lorette T. Guerrero vs. Blas Atalig/Meliton S. Santos PLS #053 Case #2017-002

No further update was made available for the Board.

5.B Jose C. Benavente vs. Paul L. Santos, PLS #053 Case #2018-006

A Special Meeting was held on April 26, 2019. At that meeting, a motion was presented to the Board to retract the Board's previous decision, made at the January 22, 2019 Board meeting to proceed with an independent investigation of Case #2018-006; and to render a decision of "No Decision." The Board voted in favor of this motion and case against Paul L. Santos, PLS #053, is now closed.

5.C APC Construction vs. Jerry B. Estrella, PE No. 1680 Case #2019-001(On Base Project)

BI Isaac submitted his investigative report to the EBA on May 1, 2019. EBA determined "Merit" at today's meeting based on unprofessional conduct. A letter of Accusation and Statement of Charges will be sent to last known address as Mr. Estrella's license was not renewed before April 30, 2019, deadline and all attempts to contact him has been unsuccessful.

5.D Amelia & Jose Garrido vs. Meliton Santos, PLS CE275/PLS053 Case #2019-002

BI Isaac submitted his investigative report to the EBA on May 9, 2019. EBA gave no determination

of Merit or No Merit in today's meeting.

Mr. and Mrs. Jose Garrido came before the Board to discuss their complaint and dismay with the

services rendered by Mr. Blas Atalig, who is an employee of Mr. Meliton Santos. AAG Keeler stated that any additional information received by the Board of this regard must be indicated as

a supplement, as BI Isaac's perimeter of investigation is limited to what was stated on the original

complaint received on April 15, 2019.

Mr. & Mrs. Jose Garrido thanked the Board for its time and left the meeting stating they will be

anxiously awaiting the determination to their case.

7.A Vernon, Walter N. PE # EE957

Mr. Vernon applied to renew his Guam registration EE957 and disclosed a Florida – FEMC Case

Nos. 2017059047. All requirements stipulated by the Florida Board had been accomplished.

Guam Board approved his registration. Although, Board wanted to review his stipulation for

rumination purposes.

7.B Fain, Jr. William H. RA275

Mr. Fain renewed his Guam architectural registration and disclosed a Nevada - Case number 18-

037N. The Engineering Board Members deferred to the Architect Board Members to clarify

"Zoning Analysis", as Planners and Architects could perform this task. This is not specific to a

discipline.

The questions expected to be clarified: Does it involve Design Work? Zoning Analysis? Planning?

When is a license required? What constitutes Architecture without a license? Would Mr. Fain's

disclosure fall under that scrutiny on Guam? The accusation of the case was based on the Nevada

law. The understanding on Guam for the Architecture requirement allows for Design work, planning, and zoning analysis. What was cited in Nevada Board is not an illegal practice on Guam.

VC Ruth explained that generally, an Architect is hired after a design development has been

approved, and plan drawings are made for the permit process. A seal is required for professional

responsibility in the Architectural field. No Guam licenses are given for Zoning or Master Planning.

It was moved by BC Jugo and seconded by Sec. & Treas. Cristi to approve Mr. Fain's renewal

registration for the license of RA275.

7.D CNMI Board Request that their Civil Engineer (CE) applicants take the California Seismic Principles Exam (CSCS) through Guam

Mr. Roy P. Reyes, PE Board Chair of the Commonwealth of the Northern Marianas Island, submitted a letter to EBA Borja stating that, similar to Guam, the CNMI has adopted the California Seismic Exam as a requisite for licensing as a Civil Engineer. However, due to the minimal applicants (one CE license request every five years), the transition to computer-based testing (CBT) of the CSCS, the process has become more onerous. Having no facilities available on Saipan to administer the exam, the CNMI Board is considering the possibility of having applicant(s) receive the ATT test through Guam's existing agreement with California.

VC Ruth motioned to deny this request as EBA Borja stated the contract with California does not allow it. Board suggests CNMI Board have interested civil candidates apply through the Guam Board prior to obtaining a CNMI license to fulfill the requirement of passing the CSCS exam. BC Jugo seconded the motion and requested to amend to state we do want to assist, although contractually, it is not possible.
